It provides affordable space and services for nonprofit Railroad Heritage Organizations (RHOs) to prepare information to be posted on their web sites for use by communities, educators, government agencies, regional history centers and the general public. PNRA reinforces the member RHOs' missions of preserving and interpreting railroad history for current and future generations.

PNRA owns and operates a 7,500 sq-ft facility in Burien, Washington, configured for the Railroad Heritage Organizations to inventory, sort, scan, catalog, and preserve their collection materials.

RHOs provide funds to support the servers. PNRA members update the sites with data generated by the RHOs.
